Description This subject explores the complex socio-political context of early childhood and school education. It will focus on the knowledge and skills related to effective management, leadership and advocacy in the education sector. This subject will engage students in review of the legal, ethical and professional accountabilities of teachers. Effective leadership and management theories, models and practices of quality educational providers will be evaluated. Students will also examine strategies for advocacy and building partnerships with families and communities. This subject is included in the Transition Phase of the Master of Teaching program.

7. Advocacy as a professional responsibility in professional practice.
8. Ethical dimensions of leadership and management.
