Description Community Engaged Learning offers students an opportunity to directly engage with communities (government, non-profits, industry) through hands-on experiences off-site from the university, including potential overseas opportunities where available. This block-mode subject fosters leadership and social responsibility through teamwork and real-world application of knowledge. It requires 60 hours of community engagement, 15 hours of workshops, and online academic support. Mandatory orientation, briefings, and debriefings are included. A Police Clearance is required before placement.

7. Leadership and advocacy toward social responsibility and analytical skills for effective intervention
8. Cross-cultural and social diversity in heritage needs/cultural perspectives
9. Lifelong learning through personal engagement with public sector and non-profit community agencies
