## Special Requirements

Legislative pre-requisites

Legislative requirements (such as a criminal record check) are not deemed necessary for students in the vascular ultrasonography course. For students who complete their clinical training in a NSW public hospital, the necessary legislative requirements will be part of their employment conditions. Clinical training for many of the students will be in a private setting, where the necessary requirements (which are likely to differ from public institutions) will be addressed as needed. Training for some students will occur in locations other than NSW (where legislative requirements can be competed if, and when required).
